Medical & Dental Benefits

Medical and Dental are effective the first of the month following your date of hire. Your cost for medical and dental benefits are based on the type of coverage you have as well as your payment tier. Golden State will cover the full cost for the first month of your medical and dental benefits, at no cost to you. After the first month, your medical and dental premium contributions will be deducted out of your paycheck.

Flexible Spending Account

We have a Flexible Spending Account that allows you to make pre-tax payroll deductions for both day care and medical expenses.

401(k) Matching

We are especially proud of our 401(k) annual match that is discretionary based on how well the company did financially the preceding year. For the last several years, we matched \$0.35 on every dollar the employee contributed to the plan (up to the IRS maximum, and not including catchup contributions).

Employee Assistance Program

Our Claremont Employee Assistance program provides mental health, legal, financial and other support referrals. Employees get five free sessions per issue per year, as well as legal and financial planning help.
